

## EX-ANTE PUBLICITY OF A NEGOTIATED PROCEDURE FOR THE AWARD OF A LOW OR MIDDLE VALUE CONTRACT UNDER THE EU FINANCIAL REGULATION

### 1. WHAT IS THIS PUBLICITY ABOUT?

The European Union Agency for the Operational Management of Large-Scale IT systems in the Area of Freedom, Security and Justice (eu-LISA) is planning to award a middle value contract for provision of mobile communication services including SIM cards for authorized personnel located in Tallinn.

The foreseen maximum value of the contract is **60,000.00 EUR** (sixty thousand euros and zero cents), excluding VAT. The initial duration of the contract will be twenty-four (24) months from the date of its entry into force, which may be automatically renewed for two additional periods of twelve (12) months, up to the total maximum of forty-eight (48) months or until the maximum value of the contract is consumed.

### 2. WHO HAS ACCESS TO EU-LISA NEGOTIATED LOW OR MIDDLE VALUE CALLS FOR TENDERS?

Under Article 179 of the EU Financial Regulation participation is open on equal terms to all natural and legal persons coming within the scope of the EU treaties or established in a third country which has a special agreement with the European Union in the field of public procurement on the conditions laid down in that agreement. This includes:

- All EU Member states and Overseas Countries and Territories.
- Parties to special or bilateral international agreement with the EU in the field of public procurement:
  - European Economic Area agreement (EEA): Iceland, Norway and Liechtenstein.
  - Stabilisation and Association Agreements (SAA): North Macedonia, Albania, Montenegro, Serbia, Bosnia and Herzegovina and Kosovo.
  - Bilateral Free Trade Agreements: parties to such agreements (see [here](#)) have access to procurement procedures of the European Commission, EEAS and the Council on their own account if the estimated value of the procedure is equal or above the thresholds established in the respective agreements and their annexes.

👉 The Contracting authority may exceptionally accept participation of economic operators from other countries without creating a precedent or obligation for the future. Please consult the details of the Funding and Tenders Portal planned call for tenders to check if such exceptional ad hoc admission is foreseen.

The rules on access to procurement do not apply to subcontractors unless a specific provision to the contrary is included in the planned call for tenders details. Subcontracting may not be used with the intent to circumvent the rules on access to procurement.

### 3. HOW TO EXPRESS INTEREST?

If you are interested in this contract, please send an email, together with the filled-in reply form, in one of the official languages of the European Union, preferably in English, no later than **the 30 of April 2026 at 17:00 EET (UTC+2)**, to the following email address:

Kindly note that the deadline of **30 of April 2026** is the time limit only for the expression of interest. Please be informed that the actual procedure will be launched after the above-mentioned deadline by sending written invitations to all economic operators which have expressed their interest as well as to any other economic operator that the contracting authority (eu-LISA) wishes to invite.

Entities established in a country that has access to the procurement (see §2) can also express interest to participate in the planned procedure by clicking on “*Express interest*” in the Funding and Tenders Portal planned call for tenders’ details page (see [Funding and Tenders Portal help page](#)).

It is possible to express interest as an individual organisation or a consortium.

Economic operators interested in the subject of this publicity are asked to note that this is **not a call for tenders**. It is a publication to announce the Contracting authority’s intention to launch a negotiated procedure for the award of a low or middle value contract and allow interested economic operators to express their interest.

of negotiated procedures for the award of middle and low value contracts (below €140,000 for services and supplies and €5,538,000 for works).

#### 4. WHERE CAN THE CALL FOR TENDERS' SPECIFICATIONS BE CONSULTED?

All the information available about the planned procedure at this stage can be found in the Funding and Tenders Portal planned call for tenders' details page.

The documentation of the actual call for tenders (invitation letter, tender specifications and draft contract) will be provided only to invited candidates when the procedure is launched in Funding and Tenders Portal.

↳ The Contracting authority reserves the right not to launch the planned procedure or to cancel or abandon it, without any right to compensation,

#### 5. WHO WILL BE INVITED TO SUBMIT A TENDER?

Only invited candidates having received an invitation to tender from the Contracting authority may participate in the planned procedure.

Consequently, any tender received from a legal or natural person not invited to tender, even if in a consortium with an invited candidate, will be rejected. Therefore, if it is the case, please express your interest as a consortium. As an alternative, you may freely use subcontracting when submitting an offer.

If you have expressed interest in this publicity and you have access to the procurement (see § 2), you will be invited to submit a tender. The Contracting authority reserves the right to invite also other economic operators than those having expressed interest following this ex-ante publicity.

↳ Invited candidates can submit a joint tender with other economic operators only if they have expressed interest in the planned procedure as a consortium.

Subcontracting is permitted.

#### 6. HOW IS YOUR PERSONAL DATA PROTECTED?

If processing your expression of interest involves the recording and processing of personal data (such as name, address and CV), such data will be processed pursuant to Regulation (EU) 2018/1725<sup>2</sup> of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free
