

PROTECTION OF YOUR PERSONAL DATA

This privacy statement provides information about the processing and the protection of your personal data

1. Introduction

The European Agency for the operational management of large-scale IT systems in the area of freedom, security and justice (hereafter, 'eu-LISA') is committed to protect your personal data and to respect your privacy. eu-LISA collects and further processes personal data pursuant to Regulation (EU) 2018/1725 of the European Parliament and of the Council of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data (repealing Regulation (EC) No 45/2001).

This privacy statement explains the reason for the processing of your personal data, the way we collect, handle and ensure protection of all personal data provided, how that information is used and what rights you have in relation to your personal data.

The information in relation to processing operation **eu-LISA Events – Call for expression of interest** undertaken by the Strategy, Capabilities and Coordination Unit of eu-LISA is presented below.

2. Why and how do we process your personal data?

The Strategy, Capabilities and Coordination Unit uses your personal data to collect information from representatives of industry, public and third sector organisations, as well as private individuals expressing interest in presenting at events organised by eu-LISA.

Data will be collected using an online survey platform provided by DG DIGIT (<https://ec.europa.eu/eusurvey/>). Upon closing the survey, data will be extracted for further processing in MS Excel data format and stored on eu-LISA shared drives.

Your personal data will not be used for an automated decision-making including profiling.

3. On what legal ground(s) do we process your personal data

We process your personal data, because:

(a) the data is necessary for the organisation of public events managed by the Agency, which are an essential part of the functioning of the Agency, as per Article 34 of the Agency's Establishing regulation (Regulation (EU) 2018/1726, OJ L 295, 21/11/2018, p. 99-137).

(b) the data subject has given consent to the processing of his or her personal data for one or more specific purposes – with respect to the personal data marked as ‘optional’.

4. Which personal data do we collect and further process?

In order to carry out this processing operation the Strategy, Capabilities and Coordination Unit collects the following categories of personal data: title (optional), first name, last name, function (optional), organisation, email address and phone number. In addition, IP address for each server request is collected by DG DIGIT as the EU Survey service provider for security reasons.

The provision of personal data is not mandatory only with respect to the data marked as ‘optional’.

5. How long do we keep your personal data?

The Strategy, Capabilities and Coordination Unit only keeps your personal data for the time necessary to fulfil the purpose of collection or further processing. The data is kept on the EU Survey platform for 2 weeks as of the last date of data collection announced in the respective questionnaire. The data extracted from the EU Survey platform, will be stored on eu-LISA and included on the mailing list related to inform on future Event - calls for expression of interest.

6. Who has access to your personal data and to whom is it disclosed?

Access to your personal data is provided to eu-LISA personnel responsible for carrying out this processing operation and to authorised personnel according to the ‘need to know’ principle. Such personnel abide by statutory, and when required, additional confidentiality agreements. DG DIGIT as data processor does not have access to your personal data; however, the IP of every connection is saved for security reasons for every server request.

The information we collect will not be given to any third party, except to the extent and for the purpose we may be required to do so by law.

7. What are your rights and how can you exercise them?

You have specific rights as a ‘data subject’ under Chapter III (Articles 14-25) of Regulation (EU) 2018/1725, in particular the right to access, rectify or erase your personal data and the right to restrict the processing of your personal data. Where applicable, you also have the right to object to the processing or the right to data portability.

With respect to the data marked as ‘optional’, you have consented to provide your personal data to the Strategy, Capabilities and Coordination Unit for the present processing operation. You can withdraw your consent at any time by notifying the Data Controller. The withdrawal will not affect the lawfulness of the processing carried out before you have withdrawn the consent. You can exercise your rights by contacting the Data Controller, or in case of conflict the Data Protection Officer. If necessary, you can also address the European Data Protection Supervisor.
